
Example of how this applies to an investor¹

Ben had AUD \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of AUD \$752 (that is 7.52% of his initial AUD \$10,000). Ben also paid AUD \$0.00 in other charges. This gives Ben a total return after tax of AUD \$752 for the period.
